

**DECLARATION OF CONTENT POSTED AT DEVIANTART BY BRAND ANGEL GIRL  
BRIANNA, DECLARATION OF THE AGE OF THE CHARACTERS POSTED AT  
DEVIANTART, FALSE ACCUSATION BY DEVIANTART**

I, [REDACTED], the content creator and YouTuber at YouTube channel @AngelGirlBrianna, content creator at the official Angel Girl Brianna brand at [AngelGirlBrianna.com](https://www.angelgirlbrianna.com), Angel Girl Brianna DeviantArt page hereby state the follow facts under 28 U.S. Code § 1746 and subject to the penalties of perjury, I state the following:

1. My YouTube channel email address is [REDACTED]. My public contact email on my YouTube channel is at [autistic.naturist@yahoo.com](mailto:autistic.naturist@yahoo.com). My YouTube channel public handle is: @AngelGirlBrianna, and my YouTube channel hash code is UCbW4CZUEkdnfG4BIHiSTuLg. I operate the Angel Girl Brianna brand, marketed as both a nudist and a textile on Roblox/Second Life.

2. I make no real money off of my brand Angel Girl Brianna. Earning robux saves me money from having to buy more robux on Roblox.com, but I am having to spend money. I do not make USD from my brand of Angel Girl Brianna. This is my hobby activity, it's my hobby brand. I do not monetize my videos either. I do this channel and run Roblox experiences as a hobby because I enjoy it. Any robux I earn is used in further Roblox activities. My only source of income is my Supplemental Security Income (SSI) by social security due to my type one brittle diabetes and autism spectrum disorder and obsessive compulsive disorder, as well as generalized anxiety disorder. I am unable to work, but I do run the hobby brand of Angel Girl Brianna because I enjoy it. Anyways I operate Angel Girl Brianna to both educate people about the good things about nudism due to all the stigmatization and false beliefs of nudism by people, and to also have video skits and great content of this angel girl who has wonderful friends making great wallpapers, video skits, Experiences, and other great content.

3. I post Angel Girl Brianna content on DeviantArt <https://www.deviantart.com/angelgirlbrianna> as part of my brand of Angel Girl Brianna. She is 100 years old and even Ame who is my friend on Roblox, WhatsApp and on SnapChat put Angel Girl Brianna as an 35 years old character because that is my age. Angel Girl Brianna is my fantasy female angel character of myself, and I am 35 years old.

4. Anime characters can appear young, but is obvious that when an anime character has breasts and even pubic hair, it is of a woman. Breasts is something a mature woman character has. Some grown women have small breasts and some have big breasts. Still all of them are women over age 18, regardless of how they look in regard to youngness. My Second Life version of Angel Girl Brianna posted on DeviantArt has breasts and pubic hair in an adult only Second Life nude friendly places.

5. See the photo below to the proof where Angel Girl Brianna is thought of as 35 years old by Ame who is my friend from Indonesia, is on Roblox platform. She also likes to draw anime and anime characters can be adults and look young. There is no birth certificate process for anime characters so they can wrongly be misidentified as underage when that is not the case at all.

I believe DevianmtArt has wrongfully misidentified my original character as underage and that angers me. I am being accused of something potentially criminal WHEN THAT IS BULLSHIT.



6. This has been for sale on my Roblox account too. Further proof my character Angel Girl Brianna is not underage.

Also my Roblox profile has me stating I am a “noudist” meaning nudist but Roblox blocks the words “nudist” so I put noudist or noudism. Nudism is not a crime.

7. I posted different characters of the Angel Girl Brianna brand on my DeviantArt account. Cop Kate who is a police officer character in my Roblox Action Movie: The Fall of Journalist Angel Girl Brianna. Skit friends.

8. She clearly is not underage because she is a police officer. Nobody underage can be a police

officer because it is the toughest job on the planet other than being in the military. The above photo is one of my images posted on my DeviantArt account. There are no nudist images of Cop Kate character as she is not a nudist but is a police officer character. Logically police officers are over 18 years of age.

9. I have declared that Angel Girl Brianna is a nudist since when I became Angel Girl Brianna on Roblox in 2024. Using the words “Noudist”. Not only is she an adult angelic being character, she is both a nudist and a textile. My friends know I am a nudist and textile including ones who helped participate in my Roblox action video skits including Cop Kate and Raven Queen. Nudism is not illegal and even the U.S. Supreme Court said nudism and nothing more is not illegal and is not pornography. For example, content provider PureNudism.com operates all over the world including in America and Europe. Nudism is not criminal, it is not obscene.

10. On or about February 6, 2026, DeviantArt wrongfully suspended my account AngelGirlBrianna with a false accusation that I am posting sexual underage content. That is not true.

11. This is fucking bullshit. Pardon my cuss words here, but I feel like this is absolute horseshit what DeviantArt has accused me of. This is horseshit targeting a nudist and textile character.

12. They took down my page so I can't try to disprove their false accusations but they are giving me false accusations here. I will sue them and get discovery to prove them wrong. I do have screenshots of DeviantArt pages I had before my account was suspended but I will not tell how many screenshots as I don't want them to cover anything up to protect their defamatory accusation.

13. The usual characters I post on my DeviantArt account are of Foxy, Angel Girl Brianna, Raven Queen, and Kate.

14. I have a nudist license ID card on my DeviantArt pages involving Angel Girl Brianna. She is age 100 and was declared that on every nudist image of her on my DeviantArt account and had appropriately applied the “mature” label on every nudist image.

You see where it says born: January 10, 1926. That makes her 100 years old. Anime characters have no birth certificate but I clearly marked her character as over 18 years old. The context is that I am innocent of the false accusation by DeviantArt.

15. Nika Nudist of DeviantArt who I know personally informed me that DeviantArt is allowing child pornography AI generated content including what I heard was a grown men groping girl which does not declare their characters to being over age 18, they do absolutely nothing about those. I will not ask Nika Nudist to produce to me the links to post here in my affidavit as I don't want to touch this stuff. They do nothing about that content as Nika Nudist has the proof/evidence, but DeviantArt shuts down my DeviantArt page over my Angel Girl Brianna nudist content.

16. I have had an enemy since 2025 which goes all the way back to my Angel Girl Brianna Roblox account. He is a trans-gendered man who became a girl character on Roblox known as Marley. Marley had a falling out with me and my friends last year on Snapchat. After that happened, I have been under attack by presumably Marley, Marley I believe is harassing me to take me down on

different platforms my brand is under. Marley I believe has been cyber stalking me and cyber harassing me which is illegal under federal law. DeviantArt may be acting out Marley's attack against my brand or is participating in Marley's intent on his/her attack against my brand

17. Marley has a Roblox account username: @doge123867. She had an inappropriate avatar on Roblox which I exposed on both Twitter/X and YouTube (took down the YouTube video after getting harassed over it but I have screenshots of this harassment). I then got nasty comments afterwards over it by Marley and/or her alt account or alt accounts. I been getting false accusations of sexual content over a leaf bikini outfit and all of this may be tied to Marley who has been coming after me and my friends. We all been dealing with the constant attacks from Marley.



18. I asked people on X/Twitter on my official X/Twitter account (before it was wrongly suspended for unauthentic accusation which is absolute hogwash but was probably cause of a false report from Marley) if Marley's outfit was inappropriate on Roblox and people agreed with me.

19. Marley has inappropriate sexual content such was this avatar above depicted on Roblox and never gets in any trouble, never gets accused of sexual content but I do appear to get false complaints of sexual content. I believe those came from Marley. I been sending email after email to Roblox about this issue with my enemy Marley. I been dealing with the attacks by my enemy Marley.

20. After I made enemies with Marley, I been dealing with one false accusation after another, one attack after another. I believe she likely reported my content on DeviantArt as having content of a minor. It wouldn't be difficult for Marley to convince DeviantArt of this since anime characters can appear young but can be of different ages. Anime originally started in Japan, and even 30-40 year old women can look like they are 18 years old if not younger but are mature adults. Japanese adults look

younger depending on what healthy foods they eat and their DNA/genetics. I believe if it is indeed Marley who caused DeviantArt to suspend my account, then he/she has lied or made a false report to DeviantArt. I demand an investigation into this suspension.

21. I believe DeviantArt has misconstrued my Angel Girl Brianna brand content as underage sexual content. That is not true. I am not showing toddlers naked. I am not showing elementary school kids on my DeviantArt page. GOD FORBID, NO. The context of every image I have ever submitted to DeviantArt is adult anime girls, I declared Angel Girl Brianna as age 100 and she is even considered age 35 by Ame last year which the Ame artwork shows my character as being the same age as me thanks to Ame drawing a birthday celebration image for me who is from Indonesia, yes she is likely an Asian anime drawer too.

22. I am not breaking any law here. Angel Girl Brianna is not underage as a character I created in 2024 and DeviantArt is clearly defaming/libel/slandering me with such accusations which violates both state and federal anti-defamation/anti-slander laws.

25. The same wallpapers posted on DeviantArt are also posted on the official Angel Girl Brianna website and the website is not accused of sexual content involving anybody underage. 26. Angel Girl Brianna is not under-aged. All characters of my brand are not underage. Only Angel Girl Brianna and Foxy characters were being nudists on DeviantArt. Both are not underage. Both have breasts. Both are clearly adults. Anime has this issue where somebody can misconstrue a anime girl as underage not knowing the context and there being no birth certificate authority on anime characters. There clearly needs to be a birth certificate authority as I will happily register Angel Girl Brianna as being 100 years old on the internet so that the authority can be set and DeviantArt will not falsely accuse me of what they had accused me of on February 6, 2026.

27. I heard DeviantArt made the same accusations to NikaNudist on DeviantArt who clearly shows a college aged character age 18 or 19 being a licensed nudist. I have reviewed over various NikaNudist content on DeviantArt before he/she was wrongfully suspended too and he/she was upset saying that he/she had no under-aged characters being a nudist. The way DeviantArt is interpreting this is by assuming every cute anime girl is all underage which is not true. When the declaration or disclaimer is added that the character is an adult, then there should be no issue here. I will happily add disclaimers to every image to be sure everybody understands my characters are not underage if I have not already done so with the Nudist License ID Card on my DeviantArt account.

28. I declare that Angel Girl Brianna is not underage as a character of my official brand of Angel Girl Brianna. Raven Queen is not underage as she is over 40 years old, the woman who operates her character Raven Queen with her real name being [REDACTED] a mother from Washington state. Raven Queen knows I am into nudism. Cop Kate is clearly over age 18 because she is a police

officer, her wallpapers are clearly not sexual content, there are no mature aka nude images of Cop Kate on my DeviantArt account. There are no mature aka nude images of Raven Queen on my DeviantArt account. Raven Queen is over 40 years old, her character is not underage. Foxy is not underage either because the one who created Foxy the blond headed nudist is [REDACTED] from Wisconsin, USA. I have his personal cell phone number and have spoken with him over the phone regarding nudism type discussions. He can send you an affidavit that Foxy the character I have in my DeviantArt account as nudist wallpapers are not underage. They have breasts and that should indicate the character is over 18 or 18 years of age. I can ask [REDACTED] to send you an affidavit. That should suffice. I can ask [REDACTED] to send you an affidavit that her anime character and Roblox character Raven Queen is not underage.


29. I feel this false accusation by DeviantArt saying I violated their Terms of Service and Etiquette policy is defamatory. Why do they even have a "mature" label for nudist content when the nudists are clearly adults??? Nudism is clearly not illegal as nudism is practiced around the world as said on Purenudism.com. Spain made nudism completely constitutional under it's Constitution. Many European countries allow nudist colonies and nudist resorts. America has nudist colonies.

30. I never posted anything in the intent of underage at all. I intended to show nudist images of Angel Girl Brianna my original character, of Foxy who ia Damion Voegel who is also a man interested in nudism in real life as well as mud baths. He is an adult I am friends with. Nudism is wholesome. My pictures, Angel Girl Brianna may be a little sexy, but she is proud of being a nudist, that is who she is like for example a girl who is proud of what type of clothes she wears to showcase. Nudism is not a sexual crime. Nudism is not a crime at all. I have no underage content. My context for all my submitted content to DeviantArt is that Angel Girl Brianna is a mature angel girl, 100 years old is what I stated in my nudist materials. Maybe I forgot to have included that in every image, maybe not. I cannot check any of this because of my account suspension. I like a copy of my entire account data for the purpose of filing a lawsuit against DeviantArt for defamation/slander/libel.

31. It is slander/defamation/libel what DeviantArt is accusing me of. Now I fear for my life because of this false accusation. I fear I will be arrested over my over 18 years of age angel character. I fear for my life because of the false accusation by DeviantArt. I will have no choice but to file a lawsuit against DeviantArt for this false accusation of sexual content of what they deemed to be underage. I know this is bullshit. They allow worse content than what they are accusing me of, and my content is simply a textile Angel Girl Brianna and nudist Angel Girl Brianna, nudists like Foxy, Emo Angel Girl, Raven Queen who is not a nudist, Cop Kate who is not a nudist, and Second Life photos of Angel Girl Brianna which is clearly marketed as a adult platform with adults, no minors are allowed at their nudist places. Everything Angel Girl Brianna brand is not sexual content of anybody underage. They need to stop this bullshit horseshit accusation or I will file a lawsuit against DeviantArt for defamation of character, libel, slander.
