So I have proven that my works on your platform are not underage sexual content. You lied. You lied about me getting my account DATA back. I have all the evidence of your business lying. Your Section 230 immunity will not hold up in court with these scummy business practices. I can sue you.

You don't ban all anime nudist works while you ban mine claiming underage sexual content while other anime nudist images on your platform look the same as my anime character with breasts. I can prove discrimination against me. I can prove fraud, and I can prove you lied.

I will sue you, it is clear I am losing all my hard work on DeviantArt. I have evidence proving your business is engaging in fraud, malpractice, discrimination. I will sue you and I will win.


